Reports of Officers

A. Chair's Report (Timothy Perkins)

B. Vice Chair (Don Crawford)

C. Treasurer (Kenny Sernach)

Some donations came in, the bank balance is about \$3,300-\$3,500. He'd like to have a mail pick up soon. Will Hobson inquired about monthly recurring donations, which the Treasurer said was about \$80/month or a bit more, not including in-kind contributions. Peter Vandenberg offered to chip in \$10/month.

D. Secretary (Carolyn Wade)

Carolyn was unable to be present. Thanks were expressed for her providing the minutes for December.

Reports of Boards and Committees

A. Campaigns Committee (Ted):

Ted analyzed cities in Oregon with populations of at least 1,000 people to see how many Libertarians were in them to find hot spots. He found 56 cities and towns with 50-250 Libertarians. He's interested in finding ways to turn these people into volunteers, county affiliates, and delegates to the state convention. He'd also like to see if people would be interested in door-knocking.
