Secretary (Taylor Rickey)

Taylor finished submitting SEL 110s for 11 Libertarian candidates for the 2022 election. I met with Libertarian fusion candidate Raquel Moore Green to discuss Defend the Guard legislation and other goals that Libertarians and Republicans can work on together. I met with Dan Farrington the Republican I am running against as well to discuss building coalitions if either of us win how we can advance liberty in Oregon. As far as anything else, just getting caught up on minutes being busy during my campaign.

# **Reports of Boards and Committees**

# A. Campaigns (LJ Mills)

LJ reports that he was able to help out with the Newton for Oregon campaign. Taylor asked if John Newton filed his SEL 110. Because when I reached out to him he said his campaign manager was taking care of it. LJ said he heard the same thing. Peter added that he is working on the campaign and was under the impression the SEL 110 was for state races. Katy Brumbelow added that it was the same for all candidates on the Oregon ballot.

# B. Fundraising (William Johnson Jr.)

Still stuck on getting the store website up and running. Trying to establish a physical address to get the store up and running. Pablo is concerned about compliance in regards to who's address we use. Pablo would be open to volunteering his address if that is allowed. Eric recommended a fictitious company that he uses for his business, that is legally allowed to use for payment processing.

#### C. Public Relations (Will Hobson)

Will reports that he is happy that the Public Policy Board is operational and looks forward to being a part of it as a non voting member. He also went to a concert for Roger Waters concert for anti war and free Asange, and did some networking. He also created a podcast that in no way reflects the views of the Libertarian Party of Oregon. LJ wanted to host an event for the homeless in Union county and asked Will if he would be open to helping make an event. Like a gala to raise funds to combat homelessness.

#### D. Data (Pablo Serrato)

Pablo Serrato will be assuming the role of Data director and is in the process of being onboarded with the Secretary of State.

#### E. Bylaws (none)

The bylaws committee was dissolved and needs to be strikes from the agenda for future reference.

#### F. Website (Pablo Serrato)

Minutes of Meeting of Board of Directors September 21st 2022 Pablo reports that he has updated the website to include our updated bylaws that were approved from our 2022 primary election. He has also updated the news page to reflect the Public Relations committee's call for volunteers for the Public Policy Board. He has started a plan to meet the IT needs for the Public Policy Board. He noticed that the Lporegon email is sensitive and member emails are ending up in the spam and urged directors to check their spam folders.

### G.Affiliates (Katy Brumbelow)

Katy Reports that she has come to the realization that the affiliate director for the whole state is a lot and came up with an idea to break the affiliates into regions of the state to get more done. She had a great conversation with someone from Jackson County and talked with her about being more active in the party. Pablo asked for a call to action or job description to find volunteers for the affiliate committee. Will and Katy will work on the county affiliate launch on Saturday. LJ asked for something from Katy to share with the college kids at Eastern Oregon University because they are eager to volunteer and Katy said she will try to put something in a google doc.

## H. Member Development (Pablo Serrato)

Pablo reports that he put up the call to action and application for the public policy board on all our social media as a way to get members involved in the public policy board. He also wants to do the same for Katy for the affiliate committee. Peter added he had a LPO BBQ at his house in Milwaukee and he collected about 140 in cash. Will mentions he attended and it was a great time.

## A. Public Policy Board Appointments. (Will Hobson)

This is a one time appointment by the board. In the future there will be a statewide election. After evaluating the applications there is a board recommendation of 11 members of the Libertarian Party of Oregon they are; Ayden Parker, Christopher Rushford, Brendan Toliver, Katy Brumbelow, Marrion Skinner, Matt Rowe, Morley Straus, Peter VandenBerg, Sonja Stahl, Tom Busse, Travis West. Pablo Moves to

appoint 11 members of the Libertarian Party of Oregon to the Public Policy Board. And Taylor seconds. (Roll Call for the motion to appoint 11 members to the Public Policy Board. **Ayes**, Rachel Saulo, Pablo Serrato, William Johnson Jr, Taylor Rickey, Will Hobson. **Nay** none. **Abstain** Tim Sipple) the motion passes and the Public Policy Board is now filled.

# B. Code of Conduct for LPO Facebook Discord (Peter VandenBerg) (See Appendix)

Peter has put together a code of conduct in response to the official LPO Facebook and discord pages getting a little tense. With a presidential election cycle starting soon he anticipates things will get more tense and he would like to see a basic code of conduct implemented for the LPO social media. To try and keep the social media pages free of abuse and fostering a place of respect. William Johnson Jr raised concerns about Libertarian governing other Libertarians on social media. Pablo recommends blocking people personally that do not engage from good faith arguments. LJ for the sake of intellectual consistency we shouldn't go further than the constitution which is free speech. Will Hobson reminded him that the party owns the property (Social Media) and should have some kind of guidelines and ground rules. Katy informed us that we have three LPO facebook profiles. One is for all Libertarians, one for members only, and one for just any kind of discussion. She thinks it sounds odd to try and block people and call ourselves Libertarians. Eric added that the Supreme Court even agreed that it is not a violation of the first amendment to have a reasonable expectation of a group in regards to decorum.

# C. 2023 LPO Convention (Will Hobson)

We are in a holding pattern, We are waiting on Timothy who may have an alternative venue that is cheaper. And we will try to get another LPO convention committee meeting as soon as we get that information.

#### Open Forum:

Tom Busse: He wanted to thank those that appointed him to the Public Policy Board. He wanted to remind everyone that the Oregon legislature is in session until Friday, they are working on confirming appointments

Tim Sippel: Last two days he was in court being sued by the county and Secretary of State. Talking about election irregularities. The judge has not yet offered a

ruling. The whole case centers around an information request that he had regarding the 2020 election.

Katy Brumbelow: suggested finding a candidate you like and believe in and helping them as a way to get involved and help the Libertarian Party.

Pablo Serrato: Wants to promote Shira Newman for state representative district 42. He helped her make a website over the weekend and offered to help other candidates do the same. And also like her facebook page.
