2) Dates changed from:

- b) Paper Ballot Request Deadline: April 2 Last day to request a paper ballot
- c) Mailing Date: April 11 First day to mail ballots and notices
- d) LPO Election Day: April 30 Last day to receive returned ballots"

- "a) LPO Filing Deadline: April 16 Last day to file candidacy or withdrawal
- b) Paper Ballot Request Deadline: April 16 Last day to request a paper ballot
- c) Mailing Date: April 25 First day to mail ballots and notices
- d) LPO Election Day: May 12 Last day to receive returned ballots"
